### 7. Business Arising in the Consent Agenda

- Donna shared that the second review of the Draft Official Plan will take place at a 2026 meeting of the Board.

### 8. CEO Update

- Donna was pleased to share that the Annual Business Forecast Lunch in November was a resounding success. She commended Smith School of Business for bringing in expert economists who provided forecasts for the year ahead. She highlighted the significance of Minister Tangri being in attendance to announce the new SuccessionOntario.ca initiative that Kingston Economic Development is undertaking with the provincial government to support business transition of small micro businesses. SuccessionOntario.ca is set to receive its official launch at the beginning of February.
- Kingston Economic Development was named the 2025 Best Small City in Canada for Startups by StartupBlink for the Corporation’s exceptional achievements in fostering a startup ecosystem. Norman Musenigmana, Business Manager for Entrepreneurs and Startups, accepted the award on behalf of the Corporation.
- Kingston was recognized by the Intelligent Community Forum (ICF) as a Fully Certified Intelligent Community at the ICF Summit in Ho Chi Minh City, Vietnam, placing the city among just six communities worldwide and third in Canada to achieve this distinction. The certification followed a comprehensive two-day audit of Kingston led by ICF Founder and CEO Robert Bell, who evaluated the city across six pillars: connectivity, workforce development, innovation, digital inclusion, community engagement, and sustainability, and highlighted Kingston’s strong community partnerships during the summit. Donna Gillespie and Peng-Sang Cau attended the Summit to accept the Full Certification on behalf of Kingston. Individually they were invited to speak on panels at the Summit alongside global representatives. Councillor Oosterhof asked whether lessons learned during the ICF Summit could be applied to new economic solutions for the city. Donna noted that this is a great opportunity to engage municipal colleagues and support their participation at future ICF events.
- Donna reported the Ontario Vehicle Innovation Network Regional Technology Development Site (OVIN RTDS) was fully executed as directed.
- The Corporation hosted a Kingston Life Science Networking Social at HAS-Motion at the beginning of December, creating the opportunity for Helix Funding participants to connect with local leaders in the life sciences sector.
